

## **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to [www.askyanalytics.com](http://www.askyanalytics.com) and Ask Y Digital Analytics and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Ask Y Digital Analytics include [www.askyanalytics.com](http://www.askyanalytics.com) and Ask Y. The Ask Y website is a news and information site. By using the Ask Y website, you consent to the data practices described in this statement.

### **Collection of your Personal Information**

In order to better provide you with products and services offered on our Site, Ask Y may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address
- Employer
- Job Title

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. ### **Use of your Personal Information**

### **Sharing Information with Third Parties**

Ask Y does not sell, rent or lease its customer lists to third parties.

### **Tracking User Behavior**

### **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by Ask Y. ### **Use of Cookies**
